#### An Evening Service of Repentance for Abuses in the Church -

In light of the recent revelations of past sexual abuse in other dioceses and the reports regarding Archbishop McCarrick, Bishop Warfel will preside at two Evening Services of Repentance for Abuses in the Church on Thursday, September 6, 2018 at St. Ann's Cathedral in Great Falls and on Friday, September 7, 2018 at St. Patrick's Co-cathedral in Billings. Both services will begin at 7:00 PM and will include a penitential ritual followed by Eucharistic Adoration.

The last few weeks have brought a great deal of anger from laity, priests, and religious the news of some priests harming children as well as directed at bishops who have mishandled cases of sexual abuse of minors in the Church. As your bishop, I am doing public penance especially for the failure of some bishops to act appropriately to protect young people and who have failed in reflecting the holiness and integrity demanded by the Gospel.



Healing Ministry: Marriage Resolution in the Catholic

**Church.** A covenantal marriage, in the eyes of the Church, meets certain criteria, deeper and more rooted in Christianity, than its secular equivalent. The Church requires that a couple be prepared well, that they are in this for the good and growth of one another, that they enter freely, and are open to God's gift of children. That being said, couples married in a secular ceremony may firmly believe that their civil marriage does indeed have those characteristics. They have a strong marriage, based on a faith in God's presence in their lives, and are committed to their partner, permanently and in fidelity. They are truly blessed in this time and culture. Should they feel that they would like the church to recognize their union, and make it sacramental, they may have their marriage blessed in the Catholic Church through the processes of either convalidation or sanation; their baptismal records will reflect their decision and they will have what the church may call a regular marriage.

When a marriage fails, there may have been conditions at the time of the wedding that hinder or preclude any of the conditions that the Church deems crucial to a sacramental covenant. The process of annulment is provided for such situations. Sometimes referred to as a "Catholic divorce", marriage annulment (decree of invalidity) is connected, at the same time, far from, the civil process. By considering the attitudes and circumstances of the couple at the time of the marriage, the diocesan office of marriage, the Tribunal, makes a determination of whether those circumstances were enough to negate the covenantal nature of the marriage. There are sometimes obvious impediments, but often, hidden and dark. Back to the "Catholic divorce" moniker ~ those who work for the diocese, including the office at the chancery and those who act as advocate-procurators, consider their work to be not a paperpushing formality, but rather a *healing ministry*. Walking with a person through the process, listening to and guiding them, is a privilege and an honor; the trust is both necessary and treasured. The process of examining one's life and choices is difficult and valuable, no matter the outcome of the petition. A key part of this ministry is the recognition of God's presence in everyone involved.



Dear Sisters and Brothers.

Recent news reports have been shocking as I'm sure you all would readily agree! It was bad enough to contend with the local news reports in Montana regarding our own Chapter 11 Bankruptcy because of the claims of sexual abuse of minors by clergy and religious. Having met with a number of these victims, heard their stories and witnessed their pain, I am ashamed that a priest or religious serving for this diocese harmed children in this way. As if this wasn't bad enough, there has been the recent news reports of the credible abuse of minors and seminarians by former Cardinal McCarrick as well as the Pennsylvania Grand Jury report. And then there has been a report that Pope Francis knew something about the McCarrick situation. (I will be quick to add that I know that some of Archbishop's assertions are not factually correct.) These, of course, are coupled with international news reports already in play regarding situations in Australia, Chile, France and Ireland. Many a Catholic is saying to themselves, "Who is to be trusted?!"

That children and youth who were victims of sexual abuse by clergy or religious, whether it occurred in Montana or elsewhere, is an unspeakable crime. I am deeply sorry for what happened to them. The incidences of sexual abuse by those who sued the Diocese of Great Falls-Billings, date back before 2000. Since 2002 and the implementation of the *Charter for the Protection of Children and Young People*, there have been no claims of abuse of a minor that have come forth. However, for a man or a woman who was sexually abused as a minor, two decades or more ago doesn't matter. For them, it often feels as if it happened yesterday. Every time a new news report comes out, the crime is repeated in their psyche. They feel it viscerally. For them, it is not merely a tragic news report. It is an event that tends to linger on for years and that rarely goes away.

One of elements that makes clerical sexual abuse of a minor so horrendous is the status of the perpetrator. A priest represents Christ. When a priest so incredibly harms a young person, it can be perceived as a betrayal by God. Christ is one who is supposed to be just and loving, a Good Shepherd. Abuse undermines and can even destroy faith in the young person's heart. A priest who inflicts such abuse, rather than representing Christ, has become a representative of the devil. Secondly, a priest is a father figure to the Church community. When a priest abuses a child or a young person sexually, he commits, not only rape, but incest. Loving fathers simply do not harm their children. The spiritual and emotional harm goes deeper than any physical damage ever could.

I recently sent a longer version of this letter to all the priests of the Diocese. In that letter I said, "We must pray for victims of abuse and keep them in front of our minds. We must also pray for healing and trust to be renewed in our Church and our diocese which will only take place when concrete steps are taken to lead people to believe."

Having read through the accounts of sexual abuse that occurred in the Diocese of Great Falls-Billings, I truly am ashamed that anyone serving on behalf of the Church here could commit such malice. I am saddened that the victims yet carry the burden. I know from my

personal interactions with some of them that time has brought forth healing, but for others, they continue to be seriously affected by what happened to them in the past. These incidences may have occurred over a couple of decades ago, but there is yet a negative impact on their lives.

I believe there is also a negative impact for many of you, the parishioners of the Diocese. I have read and reviewed many comments in messages that have come to me since the week of the final hearing before Judge Pappas on August 14, 2018. August 14, 2018 also happened to be the date the Pennsylvania Grand Jury report was released. It was like a bomb going off. Coupled with expectations of Pope Francis's journey to Ireland for the World Meeting of Families and the recent debacle with Chilean bishops, all of them handing the Pope their resignations, it is not a matter that most Catholics could ignore. It truly is a travesty that any priest would sexually abuse a child, but it is also a travesty when a bishop covers up any such situation.

Clergy, either as priests or bishops, are a certain class of individuals in the minds of people. Whether clergy like it or not, people question whether a priest or bishop is trustworthy even though the number of priests or bishops who committed such sins were small. In recent communication with bishops of Region XII (Alaska, Washington, Oregon, Idaho and Montana), we have added our suggestions regarding what actions need to be taken by the body of bishops at the November USCCB meeting. Cardinal DiNardo has already listed three proposals: a full investigation for the case against Archbishop McCarrick via an Apostolic Visitation (investigation); to make reporting of misconduct by a bishop easier; and, better procedures to resolve complaints made against a bishop. These proposals will be addressed in September by the Administrative Committee at which time the agenda for the Fall USCCB meeting is planned.

As for this diocese, it is imperative that we promote and adhere to our Safe Environment program. Our parishioners need to be reassured that we, as priests and bishop, are doing our part to keep our children safe from harm. From our recent safe environment audit, it is clear that some pastors, parish staff and even parents do not take the need to adhere to our safe environment program seriously. This cannot be so! As such, there must be a renewed effort on all our parts to do more than begrudgingly providing a report. Some parishes provided nothing. Given the questions I have received from a number of parishioners regarding the safety of their children, it is imperative to assure them.

My conviction is that the priests of this diocese take their priesthood seriously. To quote an acquaintance of mine who is a writer, "...the vast majority of good priests are both in pain and have been slimed by the bad ones and the terrible decisions of their bosses." Though we face a terrible situation and a lot of questioning, I support them. Please pray for them.
